**St. Bernard Regional Catholic School will accept your child(ren) for the 2011-2012 school year and will offer them an education program that will facilitate growth and development to the best of your child(ren)'s and our potential. This, of course, is subject to the philosophy, policies, and procedures of St. Bernard Regional Catholic School and the Diocese of Greensburg.**

**In turn, I/We choose to abide by the financial agreement as stated in the policy below:**

- **10-Month Option** will be paid through the FACTS Program from August 2011 through May 2012. Automatic withdrawals will occur on the 20<sup>th</sup> of each month.
- **12-Month Option** will be paid through the FACTS Program from July 2011 through June 2012. Automatic withdrawals will occur on the 20<sup>th</sup> of each month.
- **Full Payment** of tuition will be paid in full by July 3, 2011, with a 2% discount. No discount will be granted if payment is not received by the deadline. Payment by money order or check only is to be made directly to the school. Payment by credit card does not qualify for a discount. An additional service fee may be charged for a credit card payment.
- **Half Payment** of tuition will be paid in full by July 3, 2011, with a 1% discount on your tuition payment amount and the remaining half paid in full by January 4, 2012, with a 1% discount on your tuition payment amount. The discount will not be granted if payment is not received by the deadline. Payments are to be made directly to the school. Payment by credit card does not qualify for a discount. An additional service fee may be charged for a credit card payment. *Example: Half payment of the tuition of \$4,500 is \$2,250. One percent of \$2,250 equals \$22.50. \$2,250 minus \$22.50 equals \$2,227.50.* The amount of \$2,250 must be paid in full by July 3, 2011 and by January 4, 2012. Payment by money order or check only.
